A Request for Qualifications (RFQ) was distributed and advertised for engineering services for the Water System Improvements project on February 12th, 2025. The RFQ was posted in the NY State Contract Reporter, our online website, local newspaper, and direct reach out was completed. The RFQ was due on March 17th, 2025, at 3pm. Only one response was received, and that was from HUNT EAS. We have reviewed the content and found the submission meets all requirements requested and HUNT EAS is well qualified. It is the recommendation that we award the engineering to HUNT EAS and authorize Oakley Sortore to request HUNT EAS to develop a draft agreement to be presented to the board for review and approval.

The following resolution was offered by <u>Linda Mascho</u> who moved its adoption and seconded by <u>Carolyn Carney</u>, to wit,

BOND RESOLUTION DATED MARCH 19, 2025, AUTHORIZING THE ISSUANCE OF \$104,300.00 SERIAL BONDS BY THE TOWN OF FRIENDSHIP, ALLEGANY COUNTY, NEW YORK, PURSUANT TO THE LOCAL FINANCE LAW TO FINANCE THE COST OF AN EVEREST HARDBOX STEEL 14' DUMP BOX, EVEREST OWSK9H-HD-CT PLOW, AND EVEREST W-144-HD-10 WING WITH ACCESSORIES.

WHEREAS, the Town Board of the Town of Friendship, Allegany County, New York, by resolution duly adopted on March 20, 2024, authorizing the purchase of an Everest Hardbox Steel 14' Dump Box, Everest OWSK9H-HD-CT Plow, and Everest W-144-HD-10 Wing with Accessories for use by the Town of Friendship Highway Department to be purchased at a total price of \$129,850.00, and

WHEREAS, it is now desired to provide for the financing of said equipment;

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. The purchase equipment is hereby authorized at a maximum cost of \$129,850.00.

2. The plan for the financing of said equipment is by payment of \$25,550.00 from current appropriations and by the issuance of \$104,300.00 serial bonds of said Town, pursuant to the Local Finance Law, which bonds are hereby authorized; therefore, further details pertaining to said bonds may be prescribed in another resolution or resolutions of this board.

3. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the bonds herein authorized, including renewals of said notes, is hereby delegated to the

Supervisor of said Town, the chief fiscal officer. Said notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Supervisor,

consistent with the provisions of the Local Finance Law.

4. It is hereby determined that the period of the probable usefulness of the aforesaid object or purpose is five years, pursuant to subdivision 28 of paragraph A of Section 11.00 of the Local Finance Law, and the said bonds will mature over a period not in excess of five years.

5. The faith and credit of said Town of Friendship, Allegany County, New York are hereby irrevocably pledged for the payment of the principal of and interest on said bonds as the same respectively becomes due and payable.

6. The bonds hereby authorized are declared to be "exempt bonds" under the provisions of the Internal Revenue Code of 1986 inasmuch as the Town of Friendship will not issue more than \$10,000,000.00 of bonds during the year of issue.

7. The validity of such bonds or notes or any bond anticipation notes issued in anticipation of the sale of such bonds may be contested only if:

i. Such obligations are authorized for an object or purpose for which the municipality, school district or district corporation is not authorized to expend money, or

ii. The provisions of law which should be complied with at the date of the publication of such resolution or summary thereof, or certificate, as the case may be, are not substantially complied with, and an action, suit or proceeding contesting such validity, is commenced within twenty (20) days after the date of such publication, or

iii. Such obligations are authorized in violation of the provisions of the constitution.

HIGHWAY EQUIPMENT RESERVE FUND RESOLUTION FOR EXPENDITURE OF AND FOR NECESSARY HIGHWAY EQUIPMENT

The following resolution was offered by <u>Linda Mascho</u> who moved its adoption and seconded by <u>Carolyn Carney</u>, to wit,

WHEREAS, the Town Board of the Town of Friendship has previously established a Highway Equipment Reserve Fund for the Purchase of Necessary Highway Equipment for use by the Town of Friendship Highway Department, and

WHEREAS the Town Board now wishes to adopt a resolution authorizing the withdrawal and use of up to One Hundred Sixty-Eight Thousand Eight Hundred Fifty-One Dollars (\$168,851.00) from such Highway Equipment Reserve Fund to pay the cost of purchasing (1) 2025 Mack Granite Truck in accordance with the provisions of the New York State General Municipal Law and New York State Education Law,

NOW, THEREFORE BE IT RESOLVED, AS FOLLOWS:

1. That the withdrawal and use of up to One Hundred Sixty-Eight Thousand Eight Hundred Fifty-One Dollars (\$168,851.00) from the Highway Equipment Reserve Fund for the Purchase of Necessary Highway Equipment is hereby authorized by the Town Board of the Town of Friendship.

2. That the Town Supervisor of the Town of Friendship is hereby authorized and directed to withdraw and directed to withdraw use of up to One Hundred Sixty-Eight Thousad Eight

Hundred Fifty-One Dollars (\$168,851.00) from funds already deposited into such Highway Equipment Reserve Fund for the purchase of Necessary Highway Equipment.
